María José Frápolli is a professor of Logic and Philosophy of Science at the Department of Philosophy, University of Granada. She served as an Honorary Professor at University College London (UK) from 2018 to 2022 and was a Marie Skłodowska-Curie Fellow at University College London. Prof. Frápolli has also conducted research at Warwick University, the University of Bristol, the University of Helsinki, and the University of Miami. From 2006 to 2012, she was the President of the Spanish branch of the Society of Logic, Methodology and Philosophy of Science, and she currently serves as the President of the Society for Women in (Analytic) Philosophy, Spanish branch.

Her areas of expertise include the philosophy of logic, language, and mathematics, as well as contemporary analytic philosophy and pragmatism. She also specializes in theories of truth.



Prof. Frápolli has supervised 10 PhD dissertations and is currently supervising four more. She has also overseen numerous Master's and undergraduate dissertations. Additionally, she has been the Principal Investigator on eight funded projects and was awarded a Marie Skłodowska-Curie Fellowship (Grant Agreement No. 653056) under the European Union's Horizon 2020 Research and Innovation Programme.

Regarding her experience in research evaluation, Prof. Frápolli has served as an evaluator for major Spanish research agencies, including ANEP, ANECA, and UNIBASQ. At ANEP, she was responsible for philosophy within the Arts and Humanities panel from 2006 to 2012. Internationally, she evaluates for the FWO Research Agency of the Flanders Region, where she chairs the Philosophy and Ethics panel. She also contributes as an evaluator for the European Commission's MSCA programme.

Prof. Frápolli has authored four books, edited eight, and published over one hundred scientific papers and book chapters, with approximately one third appearing in top scientific journals and publishers.
