My research activity is summarized in a total of 29 scientific publications in journals with impact index, of which 25 correspond to articles published in level 1 and level 2 journals. Focusing on the most important publications, the level 1, we want to highlight that 14 are first quartile (Q1), 11 are second quartile (Q2), 1 is JCR third quartile (Q3), and 1 are JCR fourth quartile (Q4).

I have participated and presented papers in numerous scientific congresses and conferences. national and international relevance. Also, I have made a total of four research stays (two at predoctoral level and two at postdoctoral level) in research centers international prestige that have given rise to relevant publications, such as the London Metropolitan University (predoctoral, 6 months), University of Twente (Predoctoral, 6 months) and Lisbon School of Economics & Management, Universidade de Lisboa (postdoctoral, 3 months).

As well as President of the Association AJICEDE and founding partner of it. I belong to the research group ORGANIZATIONAL CULTURE, CAPABILITIES AND KNOWLEDGE FOR THE CREATION OF VALUE and I have participated in the project of research "Green supply chain management and its impact on improving the CVA date 03/10/2023 environmental performance".

Finally, my doctoral thesis was awarded the Extraordinary Doctorate Prize of the University of Seville.

At the teaching level, I have 3 articles, two of them in Q1 and Q2 journals, several chapters in prestigious publishers, a teaching manual and teaching material. I have also participated as a guest speaker and as a speaker at international conferences on teaching innovation and I have participated as a teacher in 8 university extension and specialization courses from the Permanent Training Center (CFP) of the University of Seville.
