Part B. CV SUMMARY (max. 5000 characters, including spaces)

I have been a professor at the University of Salamanca (2000-01) and at the UAM (2001-06) and Guest Professor at the *Institut für Politikwissenschaft of the Technische Universität Darmstadt* (Germany, 2016). Also, a guest researcher at the Max-Planck Institute for the Study of Society (MPIfG) in Cologne (1996-97) and a researcher at the Research Institute for Public Administration (FOV) in Speyer, Germany (1997-2000). More recently, a visiting researcher at the Centre d'Études et de la Recherche sur la Vie Locale (CERVL), at the IEP in Bordeaux, France (2004); at the Center for Federal Studies at the University of Kent in Canterbury, (UK,

2008) and at the École d'études politiques, University of Ottawa (Canada, 2013). In 2026-2017I was Santander Fellow in Iberian and European Studies, at the European Studies Centre, St Antonys College, University of Oxford and Associate Member of Nuffield College, at the same University.

I have been editor-in-chief of the *Revista Española de Ciencia Política* for seven years and a member of the editorial board of two other international journals and two Spanish journals and have been a member of the Board of the Research Committee on Comparative Federalism and Multilevel Governance (RC28) of the International Political Science Association (IPSA). I have founded and led two research groups at my University, the GEDIP and the CIPT, and was the founding leader of the Standing Group on Public administration and Management of the Spanish Association of Political Science (AECPA). I have also acted as evaluator for 37 national and international scientific journals and for various Spanish and international research organizations and publishers. Recently, I have created and am heading a *Research Center for Multilevel Government and Territorial Policies* at UNED, which aims to address issues related to the territorial organization of power and institutional reforms filling a gap in our country, both in research and knowledge transfer as well as in dissemination and training.

I have participated in scientific meetings, with around 25 papers to Spanish and international congresses of Political Science and around 125 invited presentations in workshops and seminars at universities in more than 10 countries. My research and more than 115 publications for more than two decades have appeared in publishers and scientific journals in 7 countries, and have focused on comparative public policies and administrations, democracy in Spain, especially its quality and reforms and citizen participation at the local level; and comparative federalism, especially the varieties of federal systems and their change and reform, diversity management, intergovernmental relations, fiscal federalism and the effects of crisis on federal systems, concentrating especially on the Spanish, German and Canadian cases. I have contributed internationally to Spanish and comparative territorial issues and comparative federalism, working on reforms of federal states and other multilevel systems and different aspects of the reforms of the Spanish Autonomic State and other systems such as Germany or Canada in various fields, addressing the evolution of German federalism or possible lessons from it for Spanish reforms. In them, I have proposed some theoretical and conceptual contributions for the understanding of change and constitutional reform in federations and the explanation of the types and determinants of reforms in federal and multilevel systems looking at the comparative aspect of territorial reforms and some methodological issues of comparing federations. Alone or in co-authorship with other colleagues of my research groups I have studied the reform and dynamics of intergovernmental relations and coordination, both vertical and horizontal, in Spain, the democratic reforms, the reforms of fiscal federalism, the fiscal and welfare policies of the Spanish Autonomous Regions and the central government as a consequence of the great recession and the COVID-pandemic crises, and, more recently, on the possible responses and reforms in the face of the secessionist crisis in Catalonia.
