Part B. CV SUMMARY (max. 3500 characters, including spaces)

My research activity has focused on the study of both individual and group variables associated with school violence (bullying and cyberbullying), such as social and moral competence, motivation, social and normative adjustment, peer group, and the family.

I am, together with Prof. R. Ortega-Ruiz, co-director of the Laboratory of Studies on Convivencia and Violence Prevention (www.laecovi.com), with extensive experience in the study of interpersonal violence in children and adolescents.

I have been the Principal Investigator of different European (RIA call for the H2020 Program - 755175) and national projects (PID2020-113911RB-I00 and PSI2016-74871-R), aimed at the longitudinal analysis of social, emotional and moral competence and the understanding of the decision-making process of schoolchildren in the face of bullying and cyberbullying phenomena. I have also directed transference projects based on the design and evaluation of educational programs for the promotion of quality interpersonal relationships (Proof of Concept program, Spanish Research Agency -PDC2021-121741-I00) and a Regional Research Contract (art. 83 LOU) granted in a very competitive call of the Center of Andalusian Studies. I have published a high number of scientific articles, with relevant contributions, in collaboration of international experts in the study of bullying and cyberbullying. I have supervised ten doctoral PhD students, and I am currently supervisor of six doctoral students, three with have been granted competitive grants. I am co-editor of the journal Psychology, Society & Education. I have participated as a speaker in invited symposia (ISSBD, 2024) and I was a Guest Speaker (KeyNote) at the II World Antibullying Forum (2018, Dublin, Ireland). I have been the author and co-author of educational handbooks aimed at Teacher Training for the improvement of interpersonal relationships, published in both Spanish and English publishers. I am currently a member of the Steering Committee of the International Observatory of School Violence; member of the Board of Directors of the Scientific Association of Psychology and Education -ACIPE-, Chair of the X International Conference of Psychology and Education. Finally, and in relation with the other academic responsibilities, I am the coordinator of the inter-disciplinary PhD Social and Legal Studies in University of Córdoba and coordinate the Excellence Research Unit "Social and Behavioral Sciences". I have participated in national and European project evaluation committees continuously since 2017 (ANECA and ERC).
