Part B. CV SUMMARY (max. 5000 characters, including spaces)

Dr. Anastasia Bermudez completed her education in the UK, including a PhD (2008), an MSc in Geography (2003), an MA in Area Studies (Latin America) (1996), and a BA in Geography and Politics (1995), all at the University of London. Her studies and research have focused on international migration to Europe, Latin America, political participation and gender. Since finishing her PhD, she continued her research and teaching activities in several universities and research institutes, including: Queen Mary, University of London (UK), Universidad de Huelva (Spain), and Instituto de Estudios Sociales Avanzados (IESA/CSIC, Spain). In 2013-2015 she was based at the Center for Ethnic and Migration Studies (CEDEM), Université de Liège (Belgium), after winning a Marie Curie COFUND Fellowship.

Dr. Bermudez joined the Social Anthropology Department, Universidad de Sevilla (Spain), in 2016, after winning a 5-year *Ramón y Cajal* research position. She took this opportunity to advance her research on: intra-EU mobilities following the 2008 global financial crisis; evolution of Latin America-Europe migration flows; migrant political participation; and asylum and refugee flows into Europe, all from a gender perspective, as well as undertaking teaching activities. In 2022 she became *Profesora Titular* at the Universidad de Sevilla, and remains as Scientific Collaborator at CEDEM. She has also joined the Instituto Universitario de Estudios sobre América Latina (IEAL) at the Universidad de Sevilla. Anastasia has led several research projects as co-PI (MIGRASCAPES, NewEUmob) and PI (as Marie-Curie Fellow and funded by JISLAC) and has participated in other internationally, nationally and regionally funded projects. As part of her academic experience and research, Dr. Bermudez has acquired a wide multidisciplinary training, working and collaborating with colleagues from Human Geography, Political Science, Sociology and Anthropology.

Her publication record includes 20 articles and she has coordinated 3 special issues in national and international, peer-reviewed academic journals (11 JCR indexed and 3 more in SJR – 11 in Q1), mostly as sole or principal author. She has also published a book and co-edited two other in international and national publishers (all in SPI Q1), and has contributed at least 13 book chapters. In total, she has 144 citations in WOS (h7) and 148 in Scopus (h7). As well as presenting her research in numerous conferences, including key international and national ones in her fields (IMISCOE, LASA, AIBR, etc.), Dr. Bermudez has co-organised conferences, seminars and workshops in addition to panels at major conferences. During 2017-2019 she was the coordinator of the IMISCOE Research Cluster 'Revisiting mobilities between Europe and Latin America: the transnational circulation of people, ideas and practices in the 21st century', and in 2019 she was elected co-Chair of LASA's International Migration section. In addition, since 2018 she has been collaborating with the work of Colombia's Truth Commission (CEV) in Europe, and she has other experiences of collaboration between academia and civil society organisations at the national and local levels.
